California American Water is a regulated utility. We follow strict guidelines from federal, state, and local authorities including the U.S. Environmental Protection Agency. We carefully follow the rules of the California Public Utilities Commission, which regulates our rates and services. Any rate change must be approved by the CPUC through a thorough and transparent process.

Infrastructure Investment

Our team continuously monitors, maintains and upgrades our facilities to ensure they operate efficiently and meet all regulatory standards. This requires investing in our water system, including treatment plants, distribution system pipes, tanks, pump stations, fire hydrants and metering equipment. California American Water invests an estimated \$77 million annually into our operating systems.

Diversity Outreach Efforts


The California American Supplier Diversity Team attends national, regional, and local events and conferences to promote diversity, educate suppliers on requirements, and encourage participation in bidding.

Your business meets diversity standards if...

- It is 51% owned by one or more persons who are minorities, women, disabled verterans, or lesbian, gay, bisexual, or transgender.
- It has been certified as such by the California Supplier Clearinghouse and designated MBE, WBE, DVBE or LGBTBE.



How do I obtain certification?

The process is FREE and certification is valid for three years.

- 1. **Visit** the Supplier Clearinghouse website at: www.thesupplierclearinghouse.com.
- 2. Click on "Apply" and review the eligibility requirements.
- Download the "Supporting Documentation" listing.
 HINT: Have all the needed documentation compiled before filling out the application.
- 4. **Print** the application package, obtain notarization and mail it to the address listed. The certification process for complete applications generally takes 4-6 weeks.
